## **Detailed Updates of Exclusive Bonus Point Reward Scheme**

• Enjoy Reward equivalent to up to 3% Rebate¹ for local & overseas retail spending

Eligible Private Banking Customer² can enjoy Extra Exclusive Bonus Point Offers on designated spending with Visa

Infinite Card during the Promotion Period as detailed below:

## Detailed Updates of Priority Pass Airport Lounges Privilege (effective from 1 Feb 2025)

With effect from 1 Feb 2025, the Priority Pass Airport Lounges Privilege will be amended and the major amendments are as follows:

#### Promotion Period will be added

- The promotion period of Priority Pass Airport Lounges ("Lounges") promotion is from 1 Feb 2025 to 31 Dec 2025 (both dates inclusive) ("Promotion Period").
- Eligible Principal Cardholder of Visa Infinite Card ("Eligible Principal Cardholder") can enjoy unlimited access to the Lounges ("Complimentary Access") within the Promotion Period. Eligible Principal Cardholder must hold a valid Dah Sing Private Banking Account for the entire month in which he / she accesses the Lounges.
- If Eligible Principal Cardholder is not holding a valid Dah Sing Private Banking Account for the entire month in which he /
  she accesses the Lounges, he / she can enjoy Complimentary Access once by accumulating Eligible Spending of
  Complimentary Access<sup>3</sup> of HKD10,000 or above within the next calendar month following each access to the Lounges.
- An access fee of HKD250 per person per visit will be levied on relevant Visa Infinite Card account within 4 months after the use of the Lounges if the Eligible Principal Cardholder (a) does not fulfil the requirement mentioned above; or (b) has accompanying guest(s) and / or Supplementary Card Cardholder(s) who has / have enjoyed access to the the Lounges during the Promotion Period. The visit record is subject to the "Record of Visit" of Priority Pass.
- Visa Infinite Card Cardholders can visit www.dahsing.com/card/vippl/en for the guideline of the use of the Lounges (including the requirements for the use of Priority Pass membership card).

#### Remarks:

- 1. Example: Eligible customer can earn 60,000 Exclusive Bonus Points for Eligible Spending of Extra Bonus Point of HKD10,000, which is equivalent to 3% rebate on the basis of redeeming HKD100 gift voucher or cash rebate with every 20,000 Exclusive Bonus Points.

Please be reminded to view or download the aforesaid document on or before 30 Jun 2025. You may not be able to view or download such information after the specified timeframe.
