Dah Sing Bank Statement on Fraudulent Facebook Page and Website

(Hong Kong, 23 September, 2024) – Dah Sing Bank, Limited (the “Bank”) has become aware today that fraudsters have created a fraudulent Facebook page pretending to be Dah Sing Credit Card. The fraudulent Facebook page requests customers or members of the public to click on a web link which directs to a fraudulent Dah Sing Credit Card website at dah-sing-credit-card-xhyru.myfreesites.net. The fraudulent website in turn asks users to register their personal and financial details to claim for rewards.

The Bank hereby confirms and advises that the fraudulent Facebook page and fraudulent website have no connection with the Bank, its subsidiaries and any of its products and services. Customers and members of the public are advised to pay attention to verification badge (a blue tick at the end of our Facebook page’s name) and the official web link in the account profile (“About” page) to confirm the genuine identity of the Facebook page owner, and not to provide any personal and/or financial information to any suspicious Facebook page or website. The Bank’s official website is at www.dahsing.com. Customers and the public should check the URL from time to time, and look for the secure padlock icon in the address bar before entering any personal and/or financial information.

The Bank has reported the case to the Hong Kong Monetary Authority and the Hong Kong Police Force. Any customer or member of the public who has provided personal and/or financial information via the fraudulent Facebook page and/or fraudulent website should promptly call the Bank’s Security Alert Hotline on 2828 8159 for assistance.

Customers and the public who have fallen prey to a scam are advised to immediately report to any local Police Station or reach Anti-Deception Coordination Centre of the Police Force by calling the 24-hour "Anti-Scam Helpline 18222".
